HOW TO ENTER

Visit all Seven (7) sponsor locations (listed above) and get your passport stamped at all Seven (7) sponsor locations then at your last stop sponsor location fill in your name, phone number, email address on your passport and turn in your passport with the last sponsor location you visited.

The Tour of Boutiques giveaway contest will begin at 10:00 am Alaska Daylight Savings Time on October 11th 2025 and end at 6:00pm Alaska Daylight Savings Time on October 11th 2025 (the

“Contest Period”).

A person can only qualify once with one passport sheet for the Tour of Boutiques giveaway.

ELIGIBILITY RESTRICTIONS

The contest is open to all persons who are 18 years of age or older and who reside in the Fairbanks North Star Borough area.

Employees of Last Frontier Mediactive, LLC their licensees, their corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Fairbanks North Star Borough area and the members of their immediate families/those living in the same household are ineligible to participate or win. PRIZE

Last Frontier will collect all the qualifying passport entries (all five stamps from all participating locations) and draw one name/winner/passport on Monday October 13th 2025. The winner will be notified on Monday October 13th 2025 by 6pm.

All prizes or prize certificates may be picked up at the office of Station at the address below. The winner will forfeit any prize or prize certificate not claimed within one (3) days of winning.

There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the

item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

WINNER SELECTION AND NOTIFICATION

Decisions of station management with respect to the contest are final.

On or around October 13th 2025, one (1) grand prize winner will be randomly selected from all the Tour of boutiques qualifying passports/entries. Winner will be notified on Monday October 13th 2025 and name announced on the morning shows on October 14th 2025

Winner will be notified via telephone. If any winner cannot be contacted after two (2) days of the first notification attempt, an alternate winner will be randomly selected from the remaining qualifying eligible entries.

Winner does not need to be present to win.

Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within Two (2) days of notification attempt or prize will be forfeited and an alternate winner may be chosen by random selection from the remaining eligible entries.
